You have been issued a citation with a court date and location. Your failure to appear in court on the date specified on the citation or otherwise respond to the citation as directed may result in suspending your driver's license and driving privilege. It may also result in a warrant being issued for your arrest.

**You have the following options to respond to the citation(s):**

1. You can appear in court on the date and time specified on the uniform citation. If you are late to court, you risk not being seen by the Judge if the court has adjourned. OR
2. **Before the first court date, you can plead guilty and pay your fine and court costs in full if you wish.** <https://www.courts.mo.gov/cnet/caseNoSearch.do> If you have been issued more than one citation, you must pay for each one.

**Options to plead guilty and pay your fine:**

If you wish to pay the total fines and costs out of court by coming to the Court office at 10405 St. Charles Rock Rd St. Ann, MO, 63074, by mailing your payment, or by paying the total fines and costs online, it will avoid a court appearance, but it will have the same effect as pleading guilty in court. If you wish to plead guilty but don't have the funds to pay for your ticket, you must still come to court. You will not be taken into custody for not having money to pay, but if you fail to appear, you risk an arrest warrant being issued. If you wish the court to consider your financial conditions in assessing fines and costs or establishing a payment plan, you may fill out a "statement of financial condition." These forms are available at the court clerk's office.

- a. Use the Plead and Pay feature on Case.net. You may search for your case at <https://www.courts.mo.gov/cnet/caseNoSearch.do> (Online; additional fees may apply)
  - You will need your citation number, which can be found in the upper right-hand corner of the citation.
  - You must pay the entire amount due on your citation, plus an online processing fee.
  - Using Plead and Pay, you acknowledge the payment in full is considered a guilty plea and waiver of a court hearing to the charge on the citation.
- b. Mail the signed Plea of Guilty, Appearance, and Waiver printed on your violation and return it with a cashier's check or money order (in US dollars) for the full amount due payable to the court listed on the citation. We recommend that you send it by certified mail and return the receipt. Be sure to write the citation number(s) and your daytime phone number on the front of the cashier's check or money order—no personal checks.
